

Types

- mandatory referendum (Art. 93.1), to confirm a constitutional law on entering into an alliance (state bond) with other states or on withdrawing from that alliance
- non-mandatory referendum (Art. 93.2.), to decide on other important issues of public interest.

Problems

- Excluded areas (cannot be subject of referendum): basic rights and freedoms, taxes and levies, state budget
- Participation: every citizen of the Slovak Republic who has the right to vote in elections of the National Council (Parliament)

Called by

- Non-mandatory referendum is called by President if:
 - requested by a popular initiative signed by a minimum of 350,000 (11% of eligible voters) citizens,
 - on the basis of a resolution of the Parliament (can be requested by MPs or by Government)

Problems

- No consensus on role of direct democracy in Slovakia
